The person making the arrangement for the facility is responsible for leaving the facilities as they were before use.
- 2. The facilities are to be scheduled through the church office, and <u>fees are to be</u> <u>paid 2 weeks in advance</u>. Scheduling or arrangements may need to be modified in the event of an unexpected congregational commitment, e.g. funeral.
- 3. There is no fee for ministerial services for church members; however, honorariums will be accepted. The church organist <u>must</u> be given the right of first refusal for all weddings.
 - 4. Equipment is not to be taken from the church.
 - 5. No birdseed, rice, confetti, or glitter may be thrown inside or outside the church.
- 6. No pianos, pews or pew screens are to be removed or moved unless approved by the Session. Custodial fee is determined case by case.
 - 7. When candles are needed, use only those supplied by the church.
- 8. There will be no smoking or drinking of alcohol or use of illegal drugs on church grounds or in the building.
- 9. Final approval for building use is dependent upon the receipt of all required fees and final approval by Session.
